RE: Cycle 04 Antibody Therapy Allocations to Healthcare Partners

Cycle 04 Antibody therapy were allocated the week of 10/04 to 10/10/2021 as below. It includes the addition of Regeneron's antibody cocktail casirivimab/imdevimab for the treatment of mild to moderate coronavirus disease and the bamlanivimab/etesivimab products. In Cycle 4 the State of Illinois was allocated 1530 patient courses of bamlanivimab/etesivimab and 2844 patient courses of Regeneron's casirivimab/imdevimab.

State Allocation Process will consider the following metrics:

- **Prior utilization per teletracking reports**
- Case rate by county
- Available ICU beds in COVID Region (not all counties have ICU beds)
- Social Vulnerability Index by county (High vs. Low SVI)

Update regarding shipping delays:

- Cycle 02, 03 and 04 deliveries have been impacted due to the decreased availability of the Regeneron product for the last 2 weeks.
- IDPH has been informed that 95% of orders not received are due to this shortage.
- AmerisourceBergen has a plan to catch up on Cycle 02 and 03 by Monday 10/11/21
- **Please consider using bamlanivimab/etesivimab IV in place of regencov IV for infusions.**
- **IV Regeneron formulations may also be used for Subcutaneous dosing- please see attached.**

Any vials not accepted by healthcare partners will be re-allocated to other healthcare providers based on urgent requests to IDPH. *Note: A request does not guarantee the amount of*

Mab requested will be provided or that the request will be approved. Priority will be based on areas of the state with the greatest need.
