This one-hour webinar is essential for healthcare professionals aiming to enhance their cultural competency, a critical component in providing quality care to all patients. Understanding cultural nuances is vital for fostering an inclusive environment that respects diverse perspectives and reduces healthcare disparities. By deepening cultural awareness, healthcare providers can better navigate patient interactions, leading to improved patient outcomes and more equitable care. The training will underscore the importance of continued growth in cultural competency as a key factor in delivering effective, evidence-based healthcare.

At the conclusion of this program, participants will be able to:

- Define “cultural competency” and its significance, including the impact of healthcare disparities and key behavioral competencies in the journey toward achieving an inclusive clinical care.
- Assess personal readiness by engaging in a reflective exercise to evaluate personal understanding and readiness to foster a culturally safe environment.
- Explore and appreciate diversity using the personal iceberg model and cultural introductions to recognize and appreciate diverse perspectives and uncover personal biases.
- Reflect on insights and observations from the session, collaborate with peers to discuss key learnings and identify focus areas for future exploration.
